Washington, D.C. - House Veterans' Affairs Committee Chairman Bob Filner (D-CA) announced that President Obama signed H.R. 3219 into law. State Capitol, Sacramento, CA – Governor Arnold Schwarzenegger today responded to the Senate's failure to confirm Roger Brautigan as secretary for the California Department of Veterans Affairs (CDVA) within one year, as specified by law, by withdrawing Brautigan's nomination and immediately appointing him senior undersecretary and acting secretary of CDVA.

"Roger Brautigan is a dedicated public

servant and California veteran who defended America's freedoms for 33 years as a member of the U.S. Army," said Governor Schwarzenegger. "He has demonstrated his commitment to serving the interests of our veterans as secretary for the CDVA, and I'm proud to have him as a member of my Administration. It is extremely disappointing that the Senate has failed to confirm such an immensely qualified and dedicated veteran. In response to the Senate's failure to act, I have appointed Roger Brautigan senior undersecretary and acting secretary of CDVA, so that he can continue to provide California's veterans with the highest level of service possible."

Brautigan will continue to receive his salary of \$175,000. The position does not require Senate confirmation.

What a happy day it was for Charles Mersereau from Scotts Valley, California, a member of The American Legion Golden Gate Post 40 of San Francisco for 66 years. He returned to Esneux, Belgium this past September as a member of the Rupiper Travel WWII Tour Group.

As Charles tells the story, "Our troops were slogging their way through Belgium with wet socks, boots and clothes with little to eat. The Belgium population was notified to care for any of the troops who came knocking on their doors, and were

asked to take them in and feed them."

Charles happened upon the home of the Franchimont family, where a grandmother, mother, cousins and Hugette lived. They invited him in and fed him, dried his clothes and boots by the fire and gave him a warm bed in the attic. Charles says "it was my first encounter with a feather-tick." That visit didn't last more than two nights, when Charles had to return to battle and go back to sleeping in the mud, he remembers.

INDIANAPOLIS (October 29, 2010) -A new generation of leaders came to Indianapolis from 32 departments (states) of The American Legion. The 54 students of the National American Legion College honed their leadership, team building, communications and mentoring skills to pass the intensive course. They received diplomas from National Commander Jimmie L. Foster during a ceremony held here this morning.

Members of the class completed the six-day crash course of the nation's largest veterans organization that saw them lay a solid foundation for Legion Post revitalization in a variety of geographical settings to include a rural area, the inner city, suburban communities, a metropolitan area and a cyber Post. They were also provided the instruction and tools to construct resolutions for American Legion activities at their respective Posts for presentation at a mock District meeting.

you talk of infantry, we're talking of young men – laying out, sleeping alongside of one another and sharing death, fear and loss of brothers. I don't know what the effect of that will be on cohesion. I mean, that's what we're looking at. It's unit cohesion. It's combat effectiveness."

Foster added that the timing of such a change, while the United States is engaged in two wars, is ill-conceived. "We agree with General Amos that 'this is not a social thing. It is combat effectiveness.' I have no doubt that homosexuals have and continue to serve this country honorably. This is not about fairness, it's about military readiness," said Foster.

With a current membership of 2.4-million wartime veterans, The American Legion was founded in 1919 on the four pillars of a strong national security, veterans affairs, Americanism and youth programs. Legionnaires work for the betterment of their communities through more than 14,000 Posts across the nation.

health problems, more must be done to provide our nation's heroes with the benefits they deserve," Foster said. "About 20 new representatives are veterans, and 14 of those belong to The American Legion, so we're hoping they will lend their strong support to our legislative priorities."

Of special concern to Legion leadership is the so-called "disabled veteran tax" or "concurrent receipt" practice, by which the retirement pay of veterans is offset according to the amount of disability pay they are receiving. "Both retirement pay and disability benefits are well and truly earned, and both should be awarded fully. To do otherwise is shameful," Foster said.

While acknowledging the recent, unprecedented increase in VA funding (\$125 billion), The American Legion is requesting additional monies for the agency, mostly to support improved medical care, research and facilities. But the Legion is also offering Congress a suggestion that, if enacted, would help to offset any VA budget increase.

Legion leaders point to the fact that more than half the veteran population served by VA is eligible for Medicare benefits. Yet VA is not authorized to collect third-party reimbursement from Medicare (or Medicaid) for health services provided to veterans that have no connection to their military service.

"In a society that's trying to improve health care, reduce deficits and serve veterans, allowing VA to bill Medicare for its non-service connected care is a win-win," said Tim Tetz, legislative director for The American Legion. "Veterans pay into the Medicare system, so why shouldn't they be allowed to take advantage of it?"

Among other items of concern to The American Legion are deficiencies in the Post-9/11 G.I. Bill that provides educational benefits to veterans attending fouryear colleges and universities. Improvements can be made, says the Legion, by broadening eligibility for benefits to members of reserve units and the National Guard, as well as expanding the list of VA-approved institutions to include vocational schools and those offering online and distance learning curricula.

Peter Gaytan, executive director of The American Legion in Washington, sums up the organization's view. "Realistically, the new Congress may be hard-pressed to find a non-partisan agenda that all its members can agree on. But why not try to bridge that chasm by agreeing to honor our nation's veterans, not only by maintaining their current benefits but improving them as well?" he said.

What has been will be again, what has been done will be done again; there is nothing new under the sun. -Ecclesiastes 1:9

This quote comes to mind as I reflect on the past, present and future of veteran's claims for benefits. Recently my son and I have been looking into joining an

organization called "Sons of Union Veterans." In order to join, you must research your ancestry and show you are directly related to a Civil War Veteran. A good friend of mine did the research and dropped off the archival papers he received from the National Archives. When I read these fascinating papers and looked into the past of 148 years ago, I was surprised to see the same requirements for a Civil War Veteran as a Veteran filing a VA Claim today. Affidavits, buddy statements, physicians' examination, the NEXUS (Link) between war service disability and injury and/or disease affecting veteran after service, claim for dependency, request for burial benefits, all required to obtain a grant of benefits. Remember, Civil War Veterans were filing claims 68 years before there ever was a Veterans Administration, which was established July 30, 1930.

Let's look at where the VA is today and where our California Legion Offices are and what the future holds as it relates to the "Strategic Plan for the VA 2010-2014." Be aware this is a short article and will only highlight much of the discussion. The VA uses a statistical tool called the Monday Morning Report, which indicates the number of pending claims, those pending claims over 125 days, and the percentage of those over 125 days. It is broken down by Compensation and Pension Entitlements, Award Adjustments, Program Reviews, Other (Predecision hearings Correspondence, etc.), Pension Entitlement, Burial, Accrued, Appeals and Education. The Monday Morning Report as of November 1, 2010 indicates the for pending claims for Compensation and Pension Entitlement Nationwide is 753,563; Compensation and Pension Rating Bundles 709,772; Compensation Entitlement 673,314; Award Adjustments 103,153; Program Reviews 19,464; Other (misc. such as Pre-decision, Correspondence, Congressional, Freedom of Information Act, Quality Assurance, Correction of errors, Combination of Workload) 49,577; Pension Entitlement 62,249; Award Adjustments 73,936; Program reviews 9,573; Other (Correspondence, Congressional, Quality Assurance, Combination of Workload (veterans, survivors) 3,890; Additional Compensation and Education Workload: Burial 25,206; Accrued 3,541; Appeals 213,919; Education 129,860. Total out these numbers and you have a grand total of 2,813,017 claims. These are staggering numbers for which the VA has to contend with. Remember, like all resources, the VA is limited in the amount of funding for which employees are hired to handle this great mountain of work.

That VA work is the reason The American Legion has Veteran Service Officers, as do other Veteran Service Organizations. Our origins are this kind of work and the reason we continue to care for our veterans throughout the world. Believe it or not, the earliest assistance came from the "Grand Army of the Republic" out of the Civil War. It began to assist veterans too disabled to work in order for them to receive some sort of compensation, due to their disabilities. As time went by and the "GAR" aged, their organization began to fade away. However, -SERVICE, continued on page 4

I think that this is very important information for all to read with Income Taxes just around the corner. The article is about individual Posts and filing their income taxes. This article is worth repeating so you don't get in trouble with the IRS.

The Internal Revenue Service is pressuring some American Legion Posts across the country to justify their nonprofit, taxexempt status. Among recent developments:

American Legion Posts in a growing number of states have recently been audited and penalized - some into the tens of thousands of dollars - over veteran to non-veteran ratios on their membership rolls. American Legion Posts must be composed of no less than 75% veterans in order to maintain tax-exempt status. As a separate organization, The American Legion Auxiliary remains unaffected for now. A new law, effective with 2007 tax-year

They do such a terrific job in managing the day-to-day affairs of the Department, especially membership. Kathy Tinitali and Ashmika Singh do an outstanding job, and are responsible for the development of the membership report that is now online at the Department Web site.

We are entering the last half of this Legion Year, and membership is doing very well. Our goal this year, 106,188, is significant, and will require all of us to do our utmost to achieve this goal. The question that keeps coming up is: Will we make it? The answer is that I feel very confident that we will. Every member of the Department Membership Team: North, South and Area Chairmen are doing an excellent job, as are many at the District and Post level. Membership team members are out there meeting with the Districts and Posts, encouraging them, mentoring and providing whatever assistance they can, to ensure that membership renewals are transmitted on time.

The transmitting of membership renewals by Posts can be a problem if not transmitted in a timely manner. It causes National to send out additional renewal notices, which waste time, resources and monies that could be used for other programs, and becomes an annoyance to our members who have already paid and continue to receive the notices.

Both Department and National require that membership renewals be transmitted to Department within 30 days, even if the Post only has one (1) renewal to transmit. There are Posts where this has been, and continues to be, a recurring problem; and one which our

filings, requires small American Legion Posts - those with annual gross receipts of \$25,000.00 or less - to electronically file form 990-N (e-Postcard) with the Internal Revenue Service each year. If those Posts do not file the form, known as an e-Postcard, or a regular form 990, they face losing their tax-exempt status. The IRS began mailing educational letters in July 2007 to notify small taxexempt organizations that they may be required to file the e-Postcard. Churches are exempt from the requirement. So for American Legion Posts, the words "may be required to file" can be exchanged for "MUST file."

· The same law means that all American Legion Posts must have their own unique Employer Identification Numbers, even if they have never filed one in years. A Post cannot use the EIN of its department or national headquarters. If it does, it risks losing its tax-exempt status.

The law states that nonprofit veterans organizations must consist of "at least 75% of the members of which are past or present members of the Armed Forces of the United States and substantially all of the other members of which are individuals who are cadets or spouses, widows, widowers, ancestors or lineal descendants of past or present members of the Armed Forces of the United States...."

Membership Team is working on. It's important that all Posts understand that the membership renewal process is not complete until the renewal is transmitted, and that the use of the "per capita" tax for any reason, other than paying the members' dues, is inappropriate.

The Department of California as of this writing (October 2010), is 23rd place at National, and 2nd place in the Western Region, at 65.248% membership for 2011. This is significant, and reflects the commitment by everyone working membership. I know that we can keep this trend alive, but it will take the efforts of all of us, at all levels, to make this happen.

As you read this article, ask yourself: Have I paid my 2011 dues? If not, please take the opportunity to do so now. This year, more than ever, we need everyone to renew their membership. Consider asking a neighbor or friend that is a veteran, to join The American Legion. Invite them to your Post, make them welcome. With everyone's help this year, I know that we can achieve our membership goal.

In October and November, I visited Areas 1, 2, 3, 4 and Hollywood Post 43. I had a great time and was able to meet with many of the members of these Areas, and to learn of the membership initiatives that are ongoing.

On November 20-21, 2010, I attended the Department of Defense program "Yellow Ribbon" in Anaheim, California. This is a program designed to welcome home returning veterans, and to help them re-integrate back into our communities. country have a growing number of Sons of The American Legion (SAL) members. Among the recently audited and penalized Posts, the percentage of SAL members had been interpreted by the IRS to have exceeded the 25% limit. However, that interpretation may not always be accurate. For instance:

- The IRS does not always subtract SAL members who also happen to be veterans. Many SAL members served in the armed forces between American Legion eligibility periods. The law requires that 75% or more be veterans, not necessarily veterans eligible for American Legion membership.
- Dual Legion-SAL members should be counted only once, as veterans, and their memberships in the other organizations should not be applied against the total.
- The percentages must be accurately calculated, where the percentage of non-veteran SAL members is based on the total membership American Legion and SAL combined rather than just the Legion total.
- The percentage must be accurately calculated, where the percentage of non-veteran SAL members is based on the total membership American Legion and SAL combined rather than just the Legion total.

National Headquarters is also working with Departments, Districts and Posts to make the case to the IRS that the ratio of veteran to non-veteran members should be considered across an entire state or even the nation. The simple solution is to recruit more American Legion members. It also pays to transfer Legion members out of the National Headquarters Post and into local community Posts. The American Legion and other veteran organizations have succeeded in getting the percentage changed in the past. At one time, a Post had to maintain 90% veteran membership.

Any American Legion Post facing an IRS audit is encouraged to hire a qualified tax lawyer and certified public accountant. Quality, professional advice can often reduce penalties and fees, and even prevent a negative decision that could adversely affect a Post's nonprofit status.

John Parcher was in the Army, serving in Vietnam in 1969 and 1970 as a crew chief Huey door gunner, but he didn't want to talk about the details of his service.

If you don't use a computer or just have questions, you can telephone the IRS: 1-877-829-5500. Hours are Monday-Friday from 7:00 a.m. to 5:30 p.m. CENTRAL TIME. You may have to wait to get a representative, so be patient. You can also contact your local IRS Office to have questions answered.

The 990 and 990 N Forms were brought up last year at the National Adjutant's Conference in Indianapolis, Indiana. It is very important that Posts fill out one of the forms. If you don't make much money or have no employees, you still have to fill out a form for the IRS.

p.m. on Tuesday and tore through the couple's garage and roof. It took firefighters until dusk to control the blaze, which raged through the explosion of propane tanks that were stored in the garage.

"The home is uninhabitable," said Cyndi Foreman, fire prevention officer for the Rincon Valley Fire Department, who participated in the fire investigation. "They will not be living in this house for quite a long time." as the United States stepped out on the world stage, wars and conflicts became global and the needs of the new veterans were just as great. With the advent of WWI the American Legion was formed in 1919. According to a US Veterans Administration press release dated April 4, 2007, "4.7 million men and women served in the U.S. armed forces during World War I. They came home with injuries, illnesses and disabilities. The American Legion went to work to lobby Congress for just deserved benefits of these service veterans. Just as the Civil War Veterans received a war pension, they too felt the same." The famous controversial "Bonus March" of the 1930's was a demand on the U.S. Government to come and compensate for disabilities caused by military service. During that same decade we saw the birth of the Veteran's Administration, which was chartered to handle the health care and needs of these veterans.

Today, The American Legion provides advocacy for veterans and their dependents in all 50 states, territories and countries throughout the world. In California, the most populated state, we have three of our American Legion VA & R Offices, which employs a staff of 13. We have accredited staff in 9 VA Hospitals and receive a tremendous help from the 58 County Veteran Offices. With the California staff and help of the County Veteran Service Offices, we handle approximately 3,188 in-person interviews, file 5,525 powers of attorney, 25,392 initial claims, which include processing and reviewing 7,796 pieces of medical evidence, and information reviewing 18,249 rating decisions. Therefore, if we equate this to the VA Monday Morning Report, our offices would have a grand total workload of 60,150 assorted claims, correspondence interviews, receiving of evidence and rating decisions, giving an average of 5,013 claims worked per month. Considering a veteran population in California of approximately 3 million veterans spanning 163,696 square miles, it is an ardent task to assist in the work of a Veteran Service Officer.

Yes, as I wrote earlier, "the numbers are staggering." Now, let's look at the dollar amounts. Our VA & R offices just this past fiscal year (2009-2010) has assisted in returning federal dollars into the Golden State of California. Our veterans received \$421,794,845 in VA Awards, with an average return on Department of California investment of \$513.84. Just the first quarter of fiscal year 2010-2011, we have assisted veterans in receiving \$167,376,898 in VA awards, with a projected return on Department of California investment of \$755.26. You can see the need is great and the numbers are not going down.

You would seem to think with the WWII and Korean War veterans leaving our midst, the numbers would plateau or decline. However, this is not the case, as the conflicts in the Middle East have been going on for over 10 years. Even though we have an all-volunteer military force, as time lengthens with these conflicts, we have and will have more veterans entering into the VA system. This short information is from the VA's Strategic Plan for 2010-2014 on the challenges facing the VA, which translates to those of us who serve in the VA & R Division of The American Legion and the workload we will confront:

"VA faces an increasingly challenging operating environment. Demand for services, in terms of claims and services per client, is growing in volume and complexity, while the economic, legislative and national security contexts all present significant uncertainties. Understanding these changes – and their implications for VA – is critical to ensuring that our strategic plan will be effective and endure over the next five years. The population of Veterans and their families whom we serve is changing. Overall, Veterans and their families are developing new, more complex needs and new expectations for the care VA should provide them. The aging of America's citizens will affect VA. Vietnam Veterans, a significant percentage of the total Veteran population, are beginning to face changing health risks as they age (e.g., prostate cancer and diabetes), thereby increasing their needs for benefits and health care services. Overall, the number of aging Veterans who may need extended care is growing rapidly: the number of enrolled Veterans, 85 or older, is projected to increase 32 percent from 601,202 to 792,498 between 2009 and 2018. This group accounts for the highest usage of long-term care services. Though not all aging Veterans will require our care, the growth in this population is highly likely to increase the demand for the extended and specialized services the elderly require.

Though the overall population of Veterans has been shrinking, there continues to be a significant increase in the number of women Veterans. Women Veterans comprise 7.5 percent of the total Veteran population and nearly 5.5 percent of all Veterans who use VA health care services. By 2020, women Veterans will constitute at least 10 percent of the Veteran population and 9.5 percent of VA patients. Disability compensation has changed in recent years as the nature of combat related wounds and service-connected injuries has changed. Many of the disabilities that are increasing most rapidly in the Veteran population are those that are difficult to rate, such as PTSD. For example, new linkages to Agent Orange - specifically, prostate cancer discovered in 1996 and Type II diabetes discovered in 2001 - have contributed to the upward trend of disability ratings. As a result, the average Veteran disability rating rose from approximately 30 percent in 1995 to 41 percent in 2009, with the percentages of Veterans in the two highest disability levels growing at the fastest rates. In March 2010, Secretary Shinseki announced that the VA Gulf War Veterans' Illnesses Task Force had completed the final draft of a comprehensive report that will redefine how VA addressed the concerns of Veterans who deployed during the Gulf War in 1990 and 1991.VA has also published a proposed rule that will enable VA to grant service connection on a presumptive basis for nine specific infectious diseases associated with military service in Southwest Asia after August 2, 1990 or in Afghanistan on or after September 19, 2001. Even advances in care for Service members have implications for VA. Tremendous strides in military medicine have led to reduced mortality rates among injured U.S. Service members in Iraq and Afghanistan, compared with prior military conflicts. At the same time, and in large part due to these higher survival rates, OEF/OIF health needs tend to be different from past conflicts. Blast injuries are increasing, adding a new dimension to battlefield casualties and their care when the battle is over. These wounds often result in multiple severe injuries and disabilities requiring extended and highly specialized care, both mental and physical. These conditions often pose challenges in anticipating and responding to the demand for health care services."

As you can see, the challenges we face as we advocate for those who have served our nation require the "All Hands on Deck" approach. The message is quite clear and with organizations like ours, if we don't crusade our advocacy for veterans, "If not now, when? If not us, then who?" Who will bend the ear of our government and insure our veterans receive their fought-for benefits? Like The American Legion, we earned the right by our service to be Legionnaires and the same goes for our VA Benefits.

Governor Schwarzenegger and State Legislature Approve Budget Increase for Operation Welcome Home

On October 8, Governor Schwarzenegger signed the State Budget, Senate Bill 870, an \$87.5 billion general fund spending plan for 2010-11. This budget was California's latest budget in 30 years; 100 days had passed since a spending plan should have been in place. The state faced an estimated \$19.1 billion deficit. Legislative leaders from both parties and the Governor were deadlocked as budget negotiations dragged on. The state was preparing to issue IOUs to state contractors and the economy was showing no signs of rebounding. The final budget deal included no new taxes or fees. As a result many programs were cut or even eliminated. The one bright spot in an otherwise bleak budget compromise was that a \$5 million increase was approved for the Operation Welcome Home initiative's subvention augmentation for the County Veterans Service Officers (CVSO's). This brings the total money allocated (subvention) to the CVSO's via the state budget up to \$7.6 million.

California's veterans had been advocating for an increase in the subvention to CVSO's for many years. This money allows California counties to maintain a County Veterans Service Office to assist local veterans file for and obtain their veterans benefits. For 13 years the veterans community and the CVSO's association have advocated for full funding, but were not able to obtain more than \$2.6 million.

In February, the Governor announced his Operation Welcome Home (OWH) initiative which sought to help the 30,000 veterans discharged each year in this state. OWH seeks to connect these young veterans with benefits, education assistance, and employment help. The CVSO's are at the forefront of connecting veterans and their families with these benefits.

However, in addition to only receiving half of what the CVSO's were authorized in 1997, the counties were making cutbacks due to the economy. CVSO offices were losing positions and county funding. The governor realized that the already impacted CVSO's would be overwhelmed by the flood of new veterans steered to them by OWH. Therefore, in the Governor's May Budget Revision, he increased the subvention to the

CVSO's to the full \$11 million authorized by SB 419. The Assembly accepted this proposal in its budget and the Senate did not. It went to a conference committee to work out the difference and they decided to cut the \$8.4 million increase to about \$1 million. My office, in conjunction with The American Legion and other statewide veterans groups, went on an all out offensive to gather popular support from veterans organizations, County Boards of Supervisors, individual veterans, and individual legislators. Nineteen County Boards of Supervisors sent letters of support. Seventy-five legislators signed onto a letter requesting the full amount be put back in the budget. We followed the lead of the Governor's office and the Department of Veterans Affairs who were in strong support of the full funding all the way. Further support was built via a Capitol press conference with all major veterans organizations participating and the enlistment of four Republican members on the Joint Budget Conference Committee who requested that the committee re-open the issue.

As a result, with the help and support of so many, funding was increased for the CVSO's from \$2.6 million to \$7.6 million. In this fund is \$600,000 which is available to VSO's and others to apply for competitive grants to help veterans. The CDVA will be notifying everyone when the application process starts.

Since the CVSO's subvention is subject to yearly approval in the state budget process it is important to constantly educate the Administration and the Legislature on the importance of what CVSO's do for veterans. In 2011, Jerry Brown will become governor and 28 new state legislators will assume office. One of the Legion's legislative goals in 2011 and beyond will be to convince the Administration and the Legislature to maintain the current subvention level and if possible get it increased to the full \$11 million authorized in the Military and Veterans Code. Also, the possibility of having the subvention cut is very real as it has happened twice in the last 4 years. The Legislature sought to reduce subvention by 10% as part of an across the board cut on government services.

The Department is currently developing a legislative platform for 2011. The platform will lay out which issues the Department will actively pursue via sponsored legislation and also which issues the Department would support should a legislator want to run with it. The platform also serves as a way to inform and educate policy makers and the public about what things are important to California's veterans and their families.



San Francisco Veterans Memorial **Announces Design Team Finalists**

Prominent Local Veterans Make Good on a 75-year Promise this Veterans Day

SAN FRANCISCO, November 3, 2010 – On Wednesday, November 10, 2010 at noon, former Secretary George P. Shultz and Secretary William J. Perry, co-chairs of the San Francisco Veterans Memorial Steering Committee, will announce the three design team finalists for the San Francisco Veterans Memorial Project at a press event in Memorial Court, the site of the future memorial. Located between the War Memorial Opera House and Veterans Building, the site was always intended to have a memorial to those who have served our nation in uniform.

"We are asking people to come together to help fulfill a promise to erect a memorial that honors the people that have protected our freedom and security. This memorial will be a symbol of gratitude for their service and for the peace we enjoy as a nation," Secretary Shultz said.

The San Francisco Veterans Memorial Project will fulfill the mission and original 1920s vision for the San Francisco War Memorial Complex, with the design and installation of a Veterans Memorial in the Memorial Court situated between the War Memorial Opera House and Veterans Building. The Memorial Court site contains soils from battlefields around the world where Americans have fought for their country. The San Francisco Veterans Memorial Project will fulfill San Francisco's 75-year promise to honor the service and sacrifice of our nation's military veterans. Members of the public are invited to attend the event and to share their ideas and hopes for the new memorial with the artists by filling out a comment card located onsite.

The San Francisco Arts Commission is currently overseeing a national design competition for the memorial. The Veterans Memorial will be constructed with private funds and is planned to be formally dedicated in November 2013.

"Hundreds of artists from across the nation answered our call for artists last summer," said Director of Cultural Affairs Luis R. Cancel. "We've narrowed the field to an exceptional group of three world-class artist teams who represent diverse backgrounds and styles and who, more importantly, have experience creating powerful memorials."

The three design team finalists will submit their proposal to the Veterans Memorial Committee in spring of 2011 with the final artist to be announced in May 2011.


